"Swachh Bharat" - a mass movement to realize Gandhiji's dream of a Clean India.

1. Pledge taking:

- (a) All the employees of the Company participated in the pledge taking ceremony on October 02, 2014. The pledge was administered by the Chairman & Managing Director of the Company and Director (Personnel). Followed by pledge taking the municipal area in and around the Registered Office was cleaned by the Officers of the Company. Members of the neighbouring community including pavement dwellers were also present in front of the Registered Office during the pledge taking ceremony.
- (b) Pledge was simultaneously administered at the factories of the Company situate at 14, Mayurbhanj Road, Kolkata 700 023, P–25, Transport Depot Road, Kolkata 700 088, 5/346, Old Mahabalipuram Road, Perungudi, Chennai 600 096 and Plot No. 16A&B, Block "D", P.O. Kalyani, Dist: Nadia, Pin 741 235. Members of the community were also involved in the cleaning drive with a view to spread the awareness.
- (c) Pledge was also administered at all the Tea Gardens of the Company situate at different parts of Assam and West Bengal. The respective Garden Managers explained the importance of a cleaning and hygienic environment to all the participants. Since Tea Gardens are usually labour intensive the message had the widest possible reach.

2. <u>Interactive Meeting</u>:

The Company organized divisionwise interactive meetings on September 25, 2014 to explain the need of a clean and hygienic work environment at the same time surroundings so that clarity emerges on the subject. Apart from employees the representatives of different pressure groups were present in the interactive meetings.

3. Display of banner:

Banner on "WORK ENVIRONMENT IS YOURS, KEEP IT CLEAN AND HYGIENIC" has been displayed at all the locations of the Company on AIDA principle (Attention, Interest, Desire, Action). The attention of the neighbouring community was also drawn through such display in and around the Company's Offices and manufacturing centres so that awareness on the issue spreads.

4. Campaign:

Extensive campaingning has been made by the Company officials on "Swachh Bharat" and different cross section of the society has been updated on the subject through lucid discussion. Discussions have also been made on the utilitarian aspect of cleanliness i.e. how cleanliness contributes to work place safety, effective utilization of space, better image etc. Place of work is the place of worship transformed to a reality instead of a matter of academic nicety.

In fine, it may be mentioned that the Company took steps in the area cleanliness and hygienic environment by keeping its precincts clean.
