The Contractor is required to <u>supply and serve meal</u> as per following menu at two different Factory canteens and supply tea two times daily under the following categories-

- # No. of meals per day indicated above is on approximation basis. The exact heads shall be determined on the basis on attendance on a particular day which will be confirmed by the respective Personnel department of the Unit.
- # Employees, who do not avail the above facility, should be supplied alternative menu / fruits of equivalent amount of normal food as mutually agreed upon from time to time. The requirement of alternative menu / fruits may vary during the Hindu Ritual or Muslim Festival or illness of some personnel.
- # No deviation in the menu is acceptable.

Scope of Service

- 1. The Contractor will supply and serve cooked food daily against AYCL requisition, which will be communicated to them at 9.00 a.m. daily.
- 2. For **Category A** above, AYCL will provide necessary space for cooking, requisite Crockery & utensils, water and electricity required for the above service. Fuel would be in the scope of the Contractor. The contractor will also be responsible for regular cleaning and washing of the utensils to keep them in order.

For **Category B** above, the Contractor is supposed to bring in cooked food. The Contractor has to make adequate arrangement to keep the food hot so that warm food can be supplied during lunch hours. AYCL would provide necessary water and electricity.

- 3. The Contractor will be responsible for keep the canteens clean and in good & hygienic conditions.
- 4. The Contractor should deploy sufficient no. of employees every day for smooth running of the canteen. They should also depute one Service Manager at each Canteen responsible for distribution of food and proper cleaning of the Canteen.

General Terms and Conditions

- 1) The firm should have **(a)** valid ESI & PF Registration numbers **(b)** valid health license issued by the competent authority and **(c)** valid contract labour license.
- Earnest Money Deposit Bidders have to deposit Rs.20,000 by D.D. / Pay Order issued in favour of Andrew Yule & Co. Ltd., payable at Kolkata towards Earnest Money. EMD shall be refunded to unsuccessful bidders, after finalization of the annual rate contract without payment of any interest. For successful bidders, EMD will be converted and kept as security deposit. No interest is applicable for Security Deposit.

For bidders already enlisted with AYCL, Electrical Division, having outstanding amount more than the EMD amount or who have already submitted the EMD against our earlier tenders or who have security deposit available with us, may apply for adjustment of the same. - 4) <u>Validity of Contract</u> Contract shall remain valid for a period of one year from the date of award of contract. If the contractor does not fulfill the execution of the contract the security Deposit of the said contractor shall be forfeited. <u>Please confirm acceptance.</u>
- 5) Payment Terms Payment would be made on monthly basis within 15 days from the submission of bill duly certified by competent authority. No other payment term is acceptable. Offers with other payment terms would not be considered. However acceptance of any deviation in the above payment terms will be at the sole discretion of Andrew Yule & if the deviation is accepted, price of bidders who quote other payment terms will be loaded @ 18% per annum.
