- 10. The rates agreed between Andrew Yule & Co. Ltd and the transporter will remain valid during the currency of the contract. The rates will increase / decrease by 30% of the percentage increase/decrease in the rates of diesel (prevailing at the time of organizing the vehicle) against the diesel rate as on 01.09.2015 at Chennai. Other than the diesel price increase \ decrease, no other change in the price will be considered.
- 11. The approved contractors should take both full and part consignments of goods by trailer/truck, if necessary. - 13. Guaranteed delivery time of materials has to be clearly mentioned by the contractor well in advance, so that unloading at site will be arranged without any delay/default.
- 14. If consignments are not delivered within the transit time allowed reckoning, grace period etc. a penalty @ 2% of the total freight charges per week or part thereof subject to a maximum of 10% shall be levied. Additional grace period of two (2) days over transit time shall be allowed for computing penalty.
- 15. No intermediate transshipment of the goods will be allowed, irrespective of the destination.
- 16. FORCE MAJEURE: In case of breakdown/accident when the goods are in transit, the contractor should inform all the details immediately for taking alternate steps as well as for Insurance claims.

- 18. OCTROI PAYMENT: Whenever required Octroi payment has to be paid by you and we shall reimburse Octroi and Service charges against documents within 2 weeks time.
- 19. The rate quoted should be per kilometer basis only.
