- Arnott Sorter should be horizontal vibrating machine suitable for sorting CTC, Green or Orthodox Tea.
- The Sorter consists of 5 Wire Mesh Decks, suspended on Spring Steel Flats.
- The vibrating action is imparted to the trays by the eccentric crank shaft with the help of connecting rods.
- The decks are fitted with Stainless Steel wire-mesh of five different perforations and a mesh tensioning mechanism.
