- a. No interest will be paid on EMD. EMD of the unsuccessful bidder(s) will be refunded by ANDREW YULE & COMPANY LTD. EMD to be paid along with the Document within the last date as mentioned in SOT.
- b. The process involves Electronic Bidding for submission of Techno Commercial Bid as well as Price Bid.
- c. 3) **Distribution of Tender quantity among all the qualified bidders.**

Negotiated L1 price will be offered to other bidders whose price bid was opened. The tender quantity will be split among bidders as follows.

- a) If only one bidder (among L2, L3, L4, L5, L6, etc) agrees to match the negotiated L1 bidder's price then tender quantity will be split as follows

L1 bidder will get 70 % of Tender quantity

Other bidder who agreed to match the negotiated L1 price will get 30 % of Tender quantity

- b) If two or more bidders (among L2, L3, L4, L5, L6, etc) agree to match the negotiated

L1 bidders' price then Tender quantity will be split as follows

L1 bidder will get 60 % of Tender quantity

Next higher bidder than L1 bidder who agrees to match the negotiated L1 price (Bidder 'A') will get 25 % of Tender quantity

Next higher bidder than Bidder 'A' who agrees to match the negotiated L1 price will get 15 % of Tender quantity.

c) If none of the other bidders accept the L1 price, AYCL reserves the right to place the entire tender quantity on the L1 bidder.

4. The tenderers should indicate **rate/km/MT** for each weight slab in each State, as detailed in the Annexure I (Transformer & Accessories). The actual site address will be known at the time of dispatch only, which can be anywhere in the state mentioned in the Annexure I. The distance in kilometer will be applicable as per Motor Guide of India published by Automobile Association of India.

5. The rates agreed between Andrew Yule & Co. Ltd and the transporter will remain valid during the currency of the contract. The rates will increase / decrease by 30% of the percentage increase/decrease in the rates of diesel (prevailing at the time of organizing the vehicle) against the diesel rate as on 16.01.2017 at Chennai. Other than the diesel price increase \ decrease, no other change in the price will be considered.

6. The approved contractors should take both full and part consignments of goods by trailer/truck, if necessary. The truck/trailer has to be placed within 24 hrs of placing our demand for the same, failing which you will be liable for payment of appropriate penalty charges. Our tentative demand for placing the trucks/trailers will be intimated well in advance from time to time.

7. Materials are to be delivered within reasonable time as given below and for delay in delivery; penalty will be deducted from the bills.

8. Guaranteed delivery time of materials has to be clearly mentioned by the contractor well in advance, so that unloading at site will be arranged without any delay/default.

9. If consignments are not delivered within the transit time allowed reckoning, grace period etc. a penalty @ 2% of the total freight charges per week or part thereof subject to a maximum of 10% shall be levied. Additional grace period of two (2) days over transit time shall be allowed for computing penalty.

10. No intermediate transshipment of the goods will be allowed, irrespective of the destination.

11. FORCE MAJEURE: - In case of breakdown/accident when the goods are in transit, the contractor should inform all the details immediately for taking alternate steps as well as for Insurance claims.

12. **INSURANCE:** we will insure the material/goods after loading of the goods on your truck/trailer up to the destination point. In case insurance authority insists on producing any documentary evidence, the same should be furnished to us.

In the event of any unforeseen incidence during the transit the same should be intimated to us within 24 hrs. We will arrange Insurance survey and only after completing such formalities the material should be further moved. During this period you have to arrange for the safe custody of the material. In case of any short supply you are responsible for the same and the cost will be recovered from you.

You have to obtain the Receipted Challan from the customer/consignees for the safe receipt of the complete quantity and the same should be handed over to AYCL perungudi within seven days of delivery. One photocopy copy of the same should be enclosed along with your bill. You have to also ensure that original Cenvat copy of Gate Pass is handed over to the consignee. However as and when specific instructions are given the original Gate Pass should be returned to our Office.

The oil level in the transformer will be marked by us and it should be acknowledged by your representative /lorry driver before dispatch at our factory and the same should be reconfirmed by the consignee on receipt of transformer at their end.

Please note that shortage of any item including oil will be recovered from the bills, as the same is not covered under transit risk.

13. **OCTROI PAYMENT:** Whenever required Octroi payment has to be paid by you and we shall reimburse Octroi and Service charges against documents within 2 weeks time.

14. The rate quoted should be per kilometer basis only. Please note for evaluation and billing purpose the distance given in Motor Guide of India published by AUTOMOBILE ASSOCIATION OF INDIA (AAI) only will be considered. For the final distance if the same is not available in the guide, the nearest available distance in AAI guide will be taken and the balance distance will be evaluated and accepted mutually.

15. Your freight bill along with receipted challan of the consignee has to be produced within 7 days from the date of unloading for destinations within 500 kms and within 15/20 days for longer distances.

16. **PAYMENT:** Freight payment will normally be made in 90 days from the date of receipt of bill supported by receipted challans and no overdue charges will be paid.

Bidders who have not accepted the payment terms given above will not be qualified and their price bid will not be opened. However acceptance of any deviation in the above payment terms will be at the sole discretion of Andrew Yule & if the deviation is accepted, price of bidders who quote other payment terms will be loaded as per Andrew Yule's norms

17. **DETENTION CHARGES:** For calculating detention charges the date of material reaching the destination and date of unloading will not be considered. Nominal delay up to 2 days will not attract any detention charges. However for abnormal delay the detention charges have to be indicated in the Price bid.

18. Acknowledgement of receipt of goods by Customer: It is the responsibility of the transporters to obtain a clean receipt from the consignee for having delivered all the materials in good condition. The acknowledgement should be signed by the authorities with seal & date. If any qualifying/conditional acknowledgement is received then the transporter will be

responsibility for any claim made by the consignee. In case no acknowledgement is produced, then the transporter is liable for claim of the entire value of goods.
