**Scope of Job:**

The job consists of **Uprooting tea bushes & shade trees including distribution to labour quarter on door to door basis & Sale of Shade Trees as a package in approximately 82 Hectares** as detailed in Part B of the Tender form in the four Dooars gardens viz, Banarhat, Karballa, New Dooars & Choonabhutti Tea Estates. The entire job will be given on turn-key basis & the Contractor (preferable from in and around Jalpaiguri/Siliguri area having experience in such kind of job in Tea Estates) should complete the entire operation within the stipulated time frame & hand over leveled land free of all bushes & trees to the garden. The tender invites also commercial selling of the uprooted shade trees to the highest bidder. All liaisons with the Forest Department & obtaining of necessary permission from the authorities where-ever required shall be the responsibility of the Contractor. **Tenderers may visit the gardens & physically check the areas to be uprooted before quoting.**

**Quotation need to be submitted in two parts. In Part A commercial conditions & credentials need to be submitted. Those who fulfill the criteria mentioned hereunder shall only be eligible to participate in the main tender process which is detailed in Part B (read with annexure).**

Tenderers are advised to complete both the parts & put Part A & Part B in **two separate sealed envelopes** superscribed with the words "**Tender for Uprooting Operation Part A**" & "**Tender for Uprooting Operation Part B**". The two separate envelopes should then be put in one single envelope sealed & super scribed with the words "**Tender for uprooting - Part A & B**". **The job may be split between more than one party & management's decision in this regard shall be final & binding.** Any of the applications received may be rejected without assigning any reasons whatsoever. **Please attach Demand Draft/Bankers Cheque of Rs2,00,000/- as Earnest Money Deposit payable at Banarhat/Siliguri .**

### TERMS & CONDITIONS

1. Work is to be completed by **120 days** from the date of the order.
2. All rates quoted will remain fixed until the job is completed & NO Price revision will be allowed, for any reason, whatsoever.
3. Penalty clause shall be applicable if the job is not completed within the stipulated time in Purchase Order. Penalty will be 1/2% of Project Value for each week of delay from the scheduled date of completion, maximum of 5% of total project value.
4. Any delay or failure in the performance of either party hereto will not constitute default thereunder or give rise to any claim for damages, if any, to the extent such delays or failure of performance is caused by the concurrence such as acts of god, or the public enemy, appropriation or confiscation of facilities by Govt. Authorities, acts of war, rebellion or sabotage, fires, explosions, riots and illegal strike.
5. In case the contractor fails to execute the contract fully or partly, the purchaser shall have the right to execute the work through other agencies, as decided by the purchaser at the contractor's cost and risk after giving two weeks notice in writing.
6. All permissions from the Forest Department & other Government agencies as necessary for commercial selling shall be obtained by the party through his own arrangement & at his own cost. Necessary N.O.C. from relevant authorities as per the rules if required needs to be obtained by the party.
7. Necessary Transit Pass for carrying the timber from the garden will be obtained by the party.
8. **GST as applicable on the sale value will be charged extra & to be borne by the party.**
9. Measurement of logs will be done in the presence of garden representatives as per the standard practice of the trade for measurement (as detailed in the order). In case of any dispute in measurement, decision of the Garden Management shall be final & binding.
10. All payments for logs need to be made in advance before their lifting. Payments to be made only by Demand Draft/Bankers Cheque payable at Banarhat/Siliguri before lifting. In case of cheques, lifting will be allowed only after its realization.
11. In case of unsuccessful bidders, the EMD will be returned to them after placing of Purchase Order. Offer without Earnest Money is liable to be rejected.
12. Bidding for each item is a must. Quotation submitted in incomplete form will be rejected.
13. **Payment for uprooting will be made after deducting the Retention Money @10% from each bill value & will be refunded after six months**, if no dispute arises regarding quality, workmanship & delay in delivery/completion of the project.
14. Rates quoted for uprooting operation must be exclusive of all applicable Taxes/GST unless otherwise specifically stated in your quotation.
15. Taxes will be deducted as per statute.
16. Management reserves the right to split the order wherever found necessary with majority job to be reserved for L1.
17. All the applicable labour laws relating to deployment of labourers/employees will be strictly followed in executing the contract.
18. Quotations will be valid for 6 months.
19. Management reserves the right to reject any or all quotations, without assigning any reason whatsoever.
20. All Disputes are subject to Jalpaiguri jurisdiction only.
