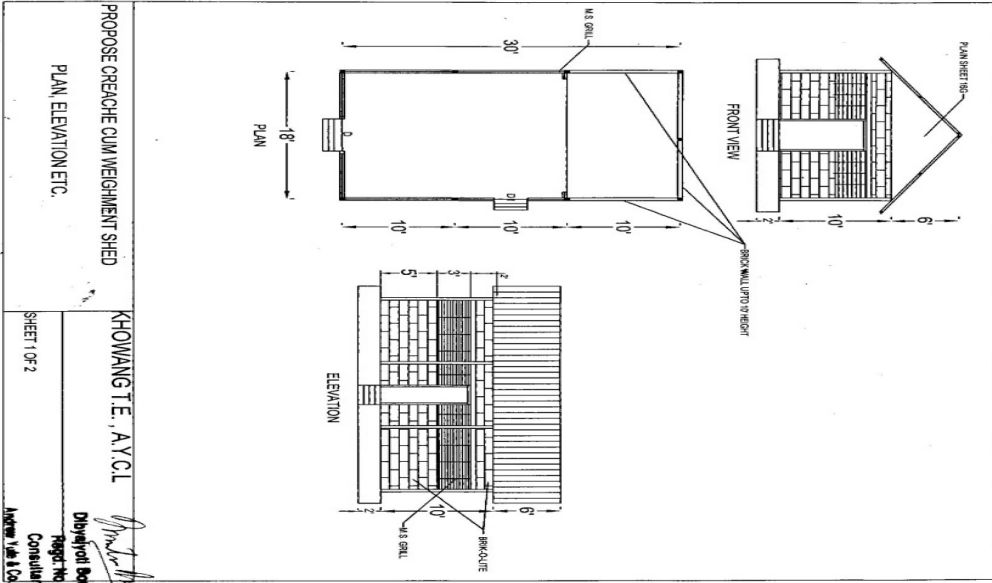

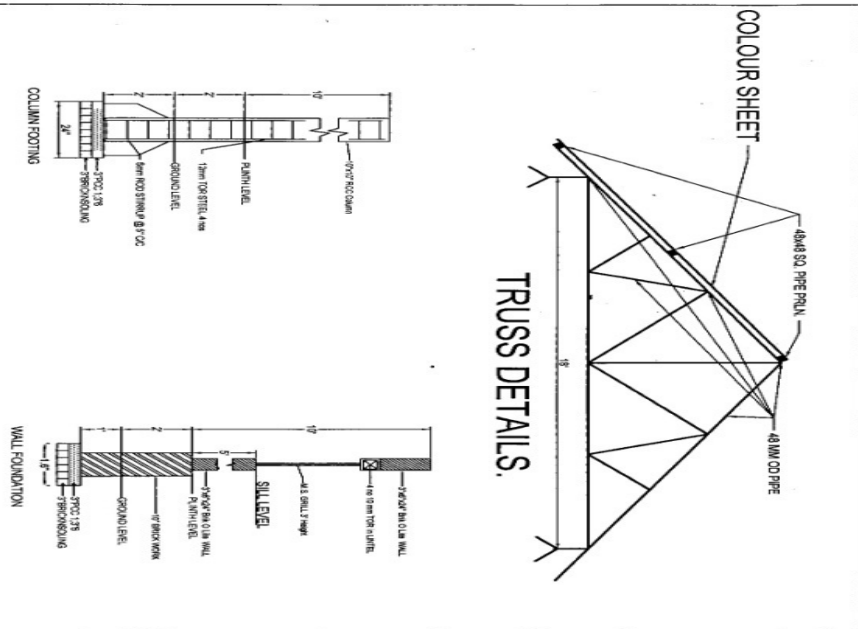


PROPOSE CREACHE CUM WEIGHMENT SHED
