subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. a. Purchase Order copy along with Invoice(s) with self-certification by the bidder that supplies against the invoices have been executed.

b. Execution certificate by client with order value.

c. Any other document in support of order execution like Third Party Inspection release note, etc.

### 8. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

It is to be noted that as per General Terms & Conditions of GeM, quoted rates in bid/RA are inclusive of taxes etc. If any bidder mentions extra GST, freight, insurance in technical/catalogue, this shall not be considered valid and no further clarification shall be sought thereof

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization.
