1. a) Eligibility Criteria:

i) **Bidder must have in-house web printing and binding facility in and around Kolkata, West Bengal.**

1. b) Scope of Work: The rates to be furnished for plate making jobs on Ex-Works basis which are to be advised by HPCL as and when required.

i) In case of Web offset operation rates to be quoted for plates of 508mm, 546mm, 560mm, 578mm cut off machine capable of delivery 1 lakh impressions.

ii) In case of Sheetfed operations separate rates to be quoted for CTP & CTCP Process for the following plate sizes.

2. Terms & Conditions:

a) Scrap generated from the operations for printing & binding including used plates will be retained by the Sub-Contractor. Consequently, the value of such scrap should be considered while submitting the rates.

b) Bidders will be allocated jobs on the basis of their equipments, manpower, working & storage space.

c) Bidders should have all statutory registration such as Trade Licence, VAT Registration, CST Registration, ESI & EPF Registration.

d) The vendor shall ensure compliance with all labour laws relating to Workmens Compensation Act, Payment of Wages Act, Minimum Wages Act, Employees' Provident Fund Act, Employees' State Insurance Act and Factories Act etc. The Company will not be responsible for any obligation, financial or otherwise which may arise due to non compliance of the aforesaid labour laws by the sub-contractor.

3. **Rate:** Rates quoted should be inclusive of all taxes and duties. However, Taxes if any to be stated separately.

4. **Validity:** The rates quoted should remain valid till 31.08.2017. The period of the validity may be extended on mutual consent for further periods of Six months.

5. **Payment Terms:** 120 (One Hundred and Twenty) days credit. Credit period to commence from the date of submission of invoice along with receipted challan and consumption statement. Income Tax and/or Sales Tax shall be deducted at source as per extant rules.

6. **Submission of Offers:** Last date for Submission of online electronic Offers is 16.09.2016 by 16.00 Hrs. The offers would be opened on the same day by 16.30 Hrs.
