Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and

its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Scope of work , General terms & Conditions

- 1. The contractor should be able to arrange vehicle with driver who can speak Tamil and English/ Hin di.
- 2. The necessary fuel and oil for running the car and the maintenance of the car are in the tenderers scope.
- 3. In case the vehicle breakdown during use, driver's negligent etc. contractor should provide an alter nate car in good condition immediately.
- 4. In case of reporting / releasing point is other than Andrew Yule, Perungudi, distance from contract or's office to the reporting/releasing point at actual kilometer and actual time in hours will be consi dered
 - 5. Your bill should be sent along with the Trip Sheet. Your trip sheet should be signed by both the driv er as well as by the user of the car at the time of closing the car with details such as starting Km &

time and closing Km & time etc.

You will be provided with a list, indicating the persons who are authorized to engage the car for Co mpany's use.

- 6. The name of the person who had booked the car should be mentioned in the trip sheet, without m entioning the user name in the trip sheet, the bill will not be processed for payment.
- 7. Your bill along with the trip sheet with full details should reach us before 15th of every month for p ayment process.
- 8. Any bill raised and delivered to us after 31 days from the last date of previous month will not be e ntertained.
- 9. Payment will be made in 45 days from the date of receipt of your bill along with trip sheet complet e in all respect.
- 10. Advance information will be given to the contractor about the requirement of cars. The contractor shall provide the required number of vehicles as & when required as per the requisition.
- 11. If there is any delay in deploying the car as per the stipulated time and for breakdown due to poor upkeep of vehicles, appropriate penalty will be levied.
- 12. In case the contractor is not able to provide cars as per the contract, the company will have the rig ht to get the requirements from other sources and any additional cost will be recovered from the p ending bills.

If the claim is more than the pending bills then the contractor has to settle the balance amount by RTGS.

- 13. Income Tax on gross amount billed will be deducted from the contractor's bills as per section 194(c) of I.T.Act.
- 14. The contractor should provide the vehicle, only as and when required by the buyer.
- 15. The contractor should able to provide up to 2 cars in a day as and when required by the buyer.
- 16. The screenshots of the opening KM at the point of pickup and closing KM at the point of final drop off are to be taken and sent to the buyer for verification of usage.
- 17. The bidder should have minimum one number of fleet of owned vehicles. The vehicles can be in th e name of agency, proprietor /partner or attached vehicles. In respect of attached vehicles, a copy

of agreement with the owner on Rs.20/- bond paper listing the vehicle numbers should be attache d.

18.Price Variation Clause (PVC)

The price variation clause will be applicable only when there is increase /decrease in fuel (Normal Diesel) price per Liter to the tune of 10% over the base price i.e diesel price prevalent at the time of commencement of contract. Variation in fuel charges for every 10% increase in the fuel price ov er and above the base rate on the date of commencement of the contract would be compensated @ 1/13th per KM.

For e.g. for a Rs.1/-per liter increase Rs.0.077 per KM would be compensated. Similarly for every 1 0% decrease in the fuel charges from the base i.e rate of Diesel prevalent at the time of commenc ement of contract, the reduced fuel charges will apply.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1

bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditons stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
