1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. 3. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Payment will be made on the basis of weight of the Consignment recorded at garden Weigh Bridge wherever possible.
- xiii. **Quantity Variation:** The quantity as indicated may vary to any extent for which the rates should remain firm.
- xiv. **Splitting of Quantity:** To ensure smooth supply within specified schedule, total quantity of order for the group may be fragmented among L1/ L2/ L3 bidders at L1 rate. However, preference towards higher allocation will be given to the lowest bidder and so on.

Decision for awarding contract / job is vested with the Management so as to reject split/fragment.
